Subject: Anthropology of Biden's Disastrous UN Resolution 2699 & the Recent Prison-Break

Dear Mr. Speaker Johnson, Honorable Members of Congress,

It is with great sadness that the New England Human Rights Organization (NEHRO) submits a summary of its latest investigative report into Haiti's horrific situation, as it relates to state-sponsored gang activities, illegal deployment of foreign troops, false impersonation of public officers (currently involving several ex-ministers, including M. Ariel Henry), privation of all the basic human rights, assassinations, mysterious deaths, serial prison-breaks to free notorious criminals associated with President Moise's assassination, in addition to acts of rape, and depopulation: all-in-one and all-at-once.

Based on the foregoing, allocating \$200 million to Mr. Henry's illicit deal with Mr. Ruto (Kenya), according to the defunct UN resolution 2699, for an illegal deployment the purported Kenyan-led multinational force to Haiti, amounts to providing material supports to a terrorizing armed gangs-alliance (see confirmation by President Biden's own •Special Envoy to Haiti: Daniel Foote). In fact, ex-Prime Minister Henry, and members of said alliance have been under fire over their clear violation of Title 22, Code of the District of Columbia, § 22–1404, in an apparent attempt, earlier this month, to offer protection to the assassins of President Jovenel Moise (see most recent prison-break at Haiti's National Penitentiary, following their fateful Washington-MOU, subjected to DC laws.

This situation calls for your direct and immediate intervention to reverse the Biden administration's perilous course. In essence, NEHRO welcomes any support from Congress to address the following concerns:

- President Biden's complicit silence, in the face of horrific human rights violations perpetrated against young girls and boys of African descent in the Americas, as the UN resolution 2699, crafted and supported by his administration awfully leaves these children behind -- repeatedly ignoring your own warnings;
- The dire situation currently ravaging Haiti reflects a wider foreign policy failure recorded in Iraq, Afghanistan, Syria, Libya, Venezuela, Ukraine and throughout the African continent, with President Biden's 50-year foreign policy influence as the common denominator;
- Credible patterns of a dangerous and erratic behavior detected in decisions taken by the Biden administration in a series of strategic dossiers, notably in Haiti's case:
 - Prof. Harold Koh believes that the Biden administration broke the law and discriminated against Haiti and Haitian citizens, in its application of Title 42 (see also Daniel Foote's testimony) and NEHRO shares their opinion with proofs in annex;
 - The Biden administration sided with gangs-affiliated, Ariel Henry, with direct connection to the assassins of President Jovenel Moise, as it chose Léon Charles over Foote and Koh, while proclaiming Henry President-for-life (see Chargé d'Affaires Stroymayer's stunning proclamation);
 - The Biden administration assists ex-Prime Minister Ariel Henry, with U.S. ambassador Linda Thomas-Greenfield in attendance, in the act of falsely impersonating a head of State during the 46th Meeting of CARICOM's heads of State in Guyana (27/02/2023);

- President Joe Biden's share of responsibilities in this preplanned prison-break at the National Penitentiary of Haiti, widely reported two weeks before its execution, with a first attempt during the fateful gathering of ex-Justice minister, Emmelie Prophete Milcé and Police Chief Frantz Elbé Washington, DC, cuddling with Biden administration officials. The final execution of the prison-break follows, interestingly, while Mr. Henry is on a mission sponsored by the Biden Administration: to create a distasteful "reciprocity" distraction with President Ruto by his side. On the cynical side of the Henry-Ruto show, however, Kenyan Police Inspector Walter Nyankieya Nyamato's family members are grieving, reconstructing, and looping shocking images of failed U.S. foreign policies: they are not alone (1.5 bilions within the African Union and more than 115 million throughout the African diaspora). Biden' team further complicates matters.
- Under Title 22, Code of the District of Columbia, Mr. Frantz Elbé (involved in illegal activities in Nairobi) et Mrs. Emmelie Prophète Milcé (falsely impersonating a public officer or a minister) have dragged the Biden administration into violation of § 22–1404 (for "...knowingly attempt to act as any such officers after his or her appointment or commission has expired or he or she has been dismissed from such office, shall suffer imprisonment in the penitentiary..." (see also § 22–704: Corrupt influence; officials);
- Under Biden administration cover, ex-Prime Minister Henry, following high-ranking official visits of Secretaries Blinken and Austin, falsely impersonated a minister in Nairobi, to perform an illegal act on the 29th day of February 2024: putting 11 million people, including American citizens, in imminent danger on Haitian soil. Crime against humanity will not have any meaning if it is not applied against Mr. Henry's conducts.

In fine, Mr. Speaker Johnson, Honorable Members of Congress, NEHRO is confident that you will find the attached report credible enough to bring these issues to the House floor, for Haiti deserves as much attention observed in Ukraine and the Middle East. The Haitian people has rejected the president-for-life regime since February 7th, 1986. It will not accept the Biden administration's indecent proposal to maintain Ariel Henry in power, as president-for-life, in connection to President Jovenel Moise's assassination and the mysterious death of a Kenyan Police Inspector in Washington, DC: both under Mr. Biden's watch. NEHRO will continue to stand tall by the Haitian people's right to self-determination. It is morally and legally the only right thing to do in this case.

Now is the time, our findings suggest, for the Biden administration to reverse its perilous course, before applying political pressure on U.S. lawmakers to pour more American taxpayers' dollars into a disastrous endeavor, as shown in Ukraine, Syria, Afghanistan, Iraq, Venezuela, Iran, and Palestine, to avoid an exhaustive list. *Indeed, it is clearly in the best interests of the United States for the Biden administration to do so.*
