Subject: *Anthropology of the Disastrous UN Resolution 2699*

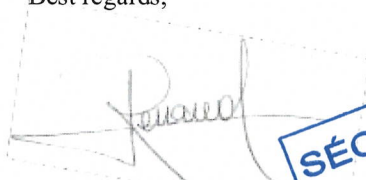
His Excellency Volker Türk,

It is with great sadness that the New England Human Rights Organization (NEHRO) submits the annexed summary of its latest investigative report into Haiti's horrific situation, as it relates to state-sponsored gang activities, illegal deployment of foreign troops, false impersonation of public officers (currently involving several ex-ministers), privation of all the basic human rights, assassinations, mysterious deaths, in addition to acts of rape, torture, and depopulation: all-in-one and all-at-once.

His excellency, this situation calls for your direct intervention, as focal point, and highest authority with the moral integrity to bring Haiti's cause, as Daniel Foote and Harold Hongju Koh have done, to levels observed in Ukraine and throughout the Middle East. In essence, NEHRO is formally requesting your assistance, cognizant of your Office's stated *mission to protect all human rights for all people, including Haitians, while prioritizing said rights in all UN operations*. Hence, we welcome any support aimed at addressing the caducity of UN resolution 2699; because it violates all the principles established in UN resolution 48/141 of December 20, 1993. Our request is summarized, according to the following quartet:

- Collaborate with NEHRO in its attempts to speak out a little louder in the face of horrific human rights violations perpetrated against young girls and boys in Haiti, as UN resolution 2699 awfully leaves them behind;
- Provide a point of contact to our organization and facilitate a consultation session with our representatives currently in Geneva, on a mission to repeal the defunct UN resolution 2699, for the latter inclines to the same horrific human rights violations previously recorded in Haiti, under the very same conditions (e.g., widespread rape of young boys and girls, Cholera, absence of offenders' accountability, highly suspicious financial arrangements, "child abandonment" by privileged UN mandated personnel: capped by a series of high-profile mysterious deaths, traumatizing people simultaneously in Washington, DC, Port-au-Prince, and Nairobi);
- Provide a forum to NEHRO, as its investigators seek to develop responses to unprecedented human rights challenges in Haiti;
- Forward the attached complaints to the UN Secretary General, following NEHRO's opportunity to discuss its strategies as well as the next steps forward with you.
